1. Meeting called to order

The meeting was called to order by President, Raymond Dziuk at 6:00 p.m.

2. Open Forum

No one spoke in open forum.

3. Annual progress report from School Health Advisory Council

Aaron Ermis gave the annual progress report of the School Health Advisory Council. They reviewed guidelines for students with food allergies. Epi pens should be on hand at school. This will be requested in next year's budget.

4. Report from Administration

Mrs. Blocker reported enrollment at 177 students in elementary and 182 on the high school campus for a total enrollment of 359. The attendance rate is 98% for both campuses. Next week we continue with state testing. The softball team won the district championship and the girl's track team won the Area championship. Four FFA leadership teams are advancing to State. Mrs. Blocker stated that dance team tryouts are tomorrow and the UIL academic regional meet will be this weekend in Brenham. Luke Jimerson and Theresa Fenner's FFA scholarship applications have advanced to the next level of competition.

5. Consider/approve minutes of the previous meetings

Jerry Jendrusch moved to approve the minutes from the previous meetings of March 20, 2013. Alfie Kowalik seconded the motion. All in favor.

6. Consider/approve payment of bills

Ms. Bettin stated that she is looking into ordering a new bus that is approximately \$89,000. It is a 71 passenger Blue Bird. Alfie Kowalik moved to approve the payment of bills as presented. Mindy Jendrusch seconded. All in favor.

7. Consider/approve resolution extending depository contract

Ms. Bettin recommended extending our current bank depository contract with Falls City National Bank. The extension is from September 1, 2013 through August 31, 2015. Mindy Jendrusch moved to approve the resolution extending the depository contract with Falls City National Bank for the next two years. Pat Jarzombek seconded the motion.

8. Consider/approve staff hires/resignations

Ms. Bettin stated that Lillian Moy will retire from her cafeteria position after 26 years. She will continue as a substitute.

9. Review Local Policy Update 96

Ms. Bettin gave board members the Board Vantage Points to review for Update 96.

10. Review Board Operating Procedures

Ms. Bettin gave Board members a copy of the Board Operating Procedures for them to review. These should be reviewed annually.

11. Review Pledge report
